- 1. The prescribed application form is available on the University website to apply online. The fee of Rs. 800 (Rs. 400/- for Female and EWS of Haryana and Rs. 200/-SC/BC/ESM/PwD candidates) may be deposited either through Net Banking or Debit Card/Credit Card & separately for each post. The Net Banking/Debit Card/Credit Card transaction charges will be extra as applicable. If the candidate applies for more than one post, he/she is required to deposit the fee separately for each post and apply separate application form.
- 2. The online application forms are available on the University website w.e.f.05.06.2023 upto **26.06.2023**.
- 3. Last date for payment of fee through Net-Banking or Debit/Credit Card is 26.06.2023.
- 4. If the candidates claims marks for Socio-Economic criteria, self-declaration Undertaking (Annexure-III) will be uploaded along with other documents.
- 5. Concession in application fee is applicable to the candidates of Haryana only.
- 6. The University reserves the right not to fill any of the post(s) advertised without assigning any reason.
