Applications on plain paper furnishing particulars of the post applied for, Name; Father's name; Date of Birth; Present Address; Permanent Address; Qualification; contact number, are invited for one (01) post of Driver of general category on ad-hoc basis for a period of six months or till regular appointments are made by Hon'ble High Court of Punjab and Haryana, Chandigarh, on consolidated pay of Rs. 25,500/- i.e. initial pay scale of the post (as per the principle of Equal Pay for Equal Work).

ESSENTIAL QUALIFICATION

The applicant should be at least middle pass with Hindi/Punjabi as one of the subject. He should possess a valid license for L.T.V. He should not have been convicted for any offence for negligent driving. The applicant should fulfill the condition of qualification on the last date of receipt of applications.

AGE LIMIT

Applicant should not be less than 18 years and more than 42 years as on 01.01.2025. Upper age limit is relaxable as per the instruction of the Hon'ble High Court and prescribed by the Haryana Government from time to time.

MODE OF SELECTION

The candidates by conducting driving test to check the practical knowledge of driving skill/rules/signs. Final selection shall be based on driving skills and interview.
