- a) Diploma in Aircraft Maintenance Engineering or Graduate in Engineering (Approved by DGCA / All India Council for Technical Education).
- b) Should have 04 years of aviation experience of which at least 01 years should be practical maintenance experience on Cessna 152 and Cessna 172 aircraft in any DGCA approved flying Training organization.

OR

- c) Working experience as 05 years of Aviation as Technician in any DGCA approved Flying Training Organization with education qualification of Matriculation with proper knowledge of English.
- d) Should be medical fit as per general Aviation Standards for performing duties as Aircraft Technician. Not more than 65 years.

## Technical Officer

### **Educational Qualification & Experience :-**
