1. Applications are invited on prescribed proforma given below from the persons (Indian Nationals) for filling up direct recruitment Group C vacancies of 61 Cavalry, Jaipur c/o Headquarters, Armoured Corps Centre and School, Ahilyanagar who fulfil the following terms and conditions:-

Important Instructions and Other Conditions

2. Age Limit. The crucial date for determining the age limit shall be the last date of receipt of application.

2.1. For EWS candidates -18 to 25 years (Relaxable for Government Servant upto 35 years as per orders/instructions issued by the Central Government).

2.2 OBC candidates - 18 to 28 years

2.3. For ST candidates - 18 to 30 years

3. Job Location. Selected candidates will be required to serve under the jurisdiction of 61 Cavalry, at Jaipur & New Delhi.

4. The benefits of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by one of the following authorities shall be accepted as proof of candidates claim as belonging to EWS -

4.1 District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner

4.2 Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate

4.3 Revenue Officer not below the rank of Tehsildar and

4.4 Sub-Divisional Officer of the area where the candidate and/ or his family normally resides.

5. All posts are temporary but likely to be permanent under Ministry of Defence with probation period of two years.

6. Candidates after selection will be subject to All India Service Liability Rules.

7. Selection will be subject to medical fitness and verification of character and antecedents from civil authorities.

8. How to Apply.

8.1 Candidates to forward application duly typed in A4 size paper as per prescribed format given in the advertisement attached with extra passport size photograph, age/caste proof, education qualification certificates so as to reach at Est Branch Headquarters Armoured Corps Centre & School, Ahilyanagar-414002 alongwith an extra self-addressed envelope (size 10.5 cm x 25 cm) with postal stamp of Rs. 5/- properly sealed for issuing call letters. If self addressed envelope and extra passport size photograph is not found enclosed, the application shall not be considered.

8.2 Incomplete application will be deemed invalid and rejected without intimation to the candidate. Admit card will NOT be issued in case of rejection/ late receipt of application and no correspondence in this regard will be entertained.

8.3 Last date for receipt of application is 21 days (including Sundays and holidays) from the date of publication of the advertisement in the Employment News and 28 days (including Sundays and holidays) for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu & Kashmir State, Lahaul and Spiti Districts and Pangi Sub Division of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep

8.4 First date of this advertisement in the 'Employment News' will be taken into account for calculating 21/28 days. If closing date falls on holidays, then next working day will be taken as closing date for receipt of application.

8.5 Department will not be responsible for any postal delay.

8.6 Persons working in Central Govt/ State Govt/ PSUs must provide the 'NOC' document obtained through the competent authority of his/her present organization to Recruitment Agency at the time of selection.

9. Written Examination and Syllabus.

9.1. Written test will be conducted in offline mode wherein 'Objective Type' questions for 150 marks will be asked. Candidates should bring their writing material and clipboard for Written Examination. Duration of examination is two hours. Question paper will be in bilingual i.e. English and Hindi and syllabus will be in accordance to minimum qualification prescribed for each post.

9.3. The selection committee has discretion to fix minimum qualifying marks for all paper or in aggregate.

9.4. There shall be no provision for re-evaluation and re-checking of the scores. No correspondence in this regard will be entertained. The decision of appointing authority regarding selection/ rejection will be final.

9.5. No Transportation Allowance/ Dearness Allowance will be admissible. Examination will be for TWO (02) to FIVE (05) days or more days depending upon number of applicants and may spread across different dates. Candidates will have to make their own arrangement for lodging/ boarding during conduct of examination.

9.6 Candidates are required to carry "Admit Card" along with identity proof (either Passport, Aadhar Card, PAN Card, Driving Licence) for confirmation while reporting for written test which should have same name as given in the application form.

9.7 Candidates will bring original certificates in support of age qualification and relevant documents on the date of test.

9.8 To restrict the number of candidates to be called for written examination, screening of applications on the basis of marks obtained in essential qualification exam on the basis of percentage of marks obtained in the said examination (matriculation)/ essential

qualification may be carried out. A benchmark percentage may be fixed depending on the number of applications.

9.9 The venue and schedule of written examination will be intimated separately to the eligible candidates only in the Admit Card.
