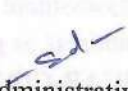
Note: -

1. Candidates are advised to read the instructions carefully.
2. Applicants must fill the application form carefully. Applicants must mention Advertisement No., Position for which applied for and Item No. of the position failing which candidature may be rejected.
3. The candidates will send their applications directly to this office at the above email address so as to reach by **31.08.2026** positively. It is mandatory to enclose with the application form the copy of requisite Degree/Provisional Degree along with mark sheets and other documents, failing which application will be rejected straight way. Merely filling up marks in the application form will not be sufficient to consider to short list the candidate for interview. It is hereby made clear that scanned copies of requisite Degree/Provisional Degree Certificate(s) must be attached with the application form along with mark sheets, failing which application will be rejected straightway.
4. There is no need to send hard copy of the application and only the applications received through email at the given email ID will be entertained. However, the candidate should bring hard copy of duly filled in prescribed application form along with CV and a passport size photo and other attested certificates at the time of interview, if found shortlisted and called for interview.
5. Applicants will be shortlisted based on their qualifying academic performance as per an assessment criterion. The short-listed candidates will be informed by this office through the email address as given by the candidates. These shortlisted candidates will undergo a panel interview at ICAR-CIRB, Hisar. Candidates are advised to clearly mention their active email IDs. Candidates are advised to get ready to appear for interview at short notice, if otherwise called for such interview.
6. The applicants must bring with them the original documents along with experience certificate(s) if any, at the time of interview.
7. No TA/DA will be paid to the candidates for attending the interview.
8. Eligible candidates who are called for interview will be required to be present at least 30 minutes before scheduled time on the date of interview for completing necessary formalities.
9. Applicants are advised to keep visiting website of this Institute for any corrigendum/update.
10. The engagement of selected candidates will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.

Other Terms and Conditions

1. The positions are purely temporary and will be filled on contractual basis as per need initially for a period of one year. However, duration of engagement can be curtailed/extended as per need and subject to performance of the candidate.

- II. The engagement will not constitute a regular job or appointment of any nature in the ICAR/CIRB.
- III. The minimum age will be 21 years and maximum 45 years for Young Professional with relaxation as per rules.
- IV. Concealing of facts or canvassing in any form will lead to disqualification of the candidate.
- V. The selected candidate will be stationed at ICAR-CIRB, Hisar and have to attend laboratory/field and office related work at this Institute.
- VI. Candidates should be willing to complete the allotted work in time. Work may be allotted based on the requirements rather than the expertise of the candidates.
- VII. The working hours will be same as regular employees of ICAR. No extra benefit will be allowed for working beyond office hours. Unauthorised absence from the work for a continuous period of 08 days without valid reasons shall lead to automatic termination of the engagement.
- VIII. The Young Professional shall have to comply with the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013.
- IX. The Young Professional shall be subject to the laws of secrecy of the country and will sign a declaration of secrecy and Non-Disclosure Agreement before reporting (Annexure-I).
- X. Intellectual Property created due to work of Young Professional during his/her valid tenure.
- XI. The candidate(s) shall not claim regular appointment at this Institute, as the position(s) is/are co-terminus with the activity or as per the need and the rules/guidelines.
- XII. All candidates are also required compulsorily to furnish the declaration duly signed in the format annexed and submit along with the application.
- XIII. During the term of engagement, the YP shall comply with the Standards of Conduct. Failure to comply with the same will become a ground for termination of the YP.
