**Subject: Head Constable (Ministerial) in Delhi Police Examination, 2025 – Shortlisting of additional candidates to appear in Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test (Skill Test).**

Candidates may refer to the result write-up dated 05.06.2026 declaring the result of Head Constable (Ministerial) in Delhi Police Examination, 2025.

2. Some of the candidates who applied under UR or EWS category have submitted their representations to the Commission regarding non-inclusion in the result of the said Examination, claiming that they should have been considered under 'OBC from the NCT of Delhi' category, as they claimed to be possessing certificate of the same.
3. The matter has been duly examined in the Commission. The candidatures of all such candidates who have claimed to be possessing the certificate for the 'OBC from the NCT of Delhi' category have also been considered for processing of the result.
4. In view of the above, fifty-one (51) additional candidates have been found eligible for shortlisting to appear in the Physical Endurance & Measurement Test (PE&MT)/Document Verification (DV)/Trade Test. The lists of the additional candidates, which have been uploaded on the website of the Commission, are as follows:
