2. Details of the application for are published on the ICAR-IARI Contractual Job Web Portal. If space is insufficient, the Application Proforma could be typed neatly or additional information could be provided in Annexures, duly signed.
3. The **walk-in interview will be held on 23/06/26** at the Division of Fruits and Horticultural Technology ICAR-IARI, New Delhi.

4. Only the candidates having essential qualifications and proper certificates would be interviewed. The candidates shall be shortlisted based on eligibility criteria, educational performance and/or relevant research experience, if applicable. No TA/DA shall be paid to attend the interview.
5. **Age Limit:** 50 years maximum (5 years' relaxation for SC/ST/OBC and woman candidates as per ICA rules). The post is purely temporary in nature and is co-terminus with the project.
6. The engagement will be purely on contractual basis, time bound, non-regular & co-terminus with the project and the incumbent shall not have any claim for regular appointment under ICAR or any further contractual engagement on termination of the project. The selected candidate shall have no legal right to claim regularization by absorption or otherwise or any further continued engagement on termination of the project.
7. The tenure of engagement will be for the term of the project, not extending beyond December 2026. The services of the incumbent shall stand terminated automatically on expiry of the period given in the offer letter. During the period of engagement, If the performance is non-satisfactory, the incumbent could be terminated from the position with one- month notice.
